ASSISTANT DIRECTORS NAMED FOR THREE
DIVISION OF BANK SUPERVISION REGIONS

The Board of Directors of the Federal Deposit Insurance Corporation today announced the selection of three Assistant Regional Directors for the Division of Bank Supervision (DBS). Sylvia J. Horne, a Review Examiner in the Memphis (Tennessee) Region, and Ronny G. Parham, Field Office Supervisor in the Memphis Regional Office, became Assistant Regional Directors in Memphis on July 30, 1989. John P. Misiewicz, Field Office Supervisor in the Fort Wayne (Indiana) Field Office, will become Assistant Regional Director in Kansas City on August 13.

DBS Director Paul G. Fritts said: "These three talented employees have progressed through the ranks of DBS and are well qualified for their new positions. I know each will do an excellent job for the division and will strengthen field operations as we take on the increased responsibilities provided by the pending thrift legislation."

Ms. Horne, 33, joined the Corporation in May 1978 as a Bank Examiner (Trainee) in the Memphis (Tennessee) Field Office in the Memphis Region. She transferred to the Hattiesburg (Mississippi) Field Office in September 1978 and to the Jackson (Mississippi) Field Office in July 1981. She was promoted to Commissioned Examiner in June 1982 and to Review Examiner in the Memphis Regional Office in September 1985.

Ms. Horne, a native of Gulfport, Mississippi, is a graduate of Mississippi State University with a B.S. degree in business. She currently is a senior at The School for Bank Administration at the University of Wisconsin in Madison.

Mr. Parham, 47, joined the Corporation in June 1964 as a Bank Examiner (Trainee) in the Tampa (Florida) Field Office in the Atlanta Region. He was drafted into the U.S. Army in May 1965 and was honorably discharged in June 1967, returning to the Corporation as an Assistant Bank Examiner in the Tampa Field Office. He was promoted to Commissioned Examiner in 1971 and to Field Office Supervisor in Albany, Georgia, in January 1980. He became supervisor of the Memphis Field Office in August 1982.

Mr. Parham, a native of Hamilton, Mississippi, is a graduate of Mississippi State University, Starkville, Mississippi, with a B.S. degree in business. He is also a graduate of The School for Bank Administration at the University of Wisconsin. He and his wife, Renee, have two sons, Sean and Rodney.

Mr. Misiewicz, 39, a native of Gardner, Massachusetts, joined the FDIC as a Bank Examiner (Trainee) in Indianapolis, Indiana, in 1968 through the Cooperative Education Program of Northeastern University, Boston, Massachusetts.

After completing his military duty as an Army officer, Mr. Misiewicz resumed his career with the FDIC in the Litchfield (Illinois), Field Office where he became a Commissioned Examiner in 1975. He was named Field Office Supervisor of the Marion (Illinois), Field Office in 1979. He assumed responsibility for the Milwaukee (Wisconsin), Field Office in 1985 and moved to the Fort Wayne (Indiana), Field Office in 1987.

Mr. Misiewicz is a graduate of Northeastern University with a B.S. degree in business administration. He is also a graduate of the Graduate School of Banking at the University of Wisconsin.

He and his wife, the former Ruth Hollenkamp of Carlyle, Illinois, are the parents of two children, Eric and Todd.
