FDIC APPROVES DEPOSIT ASSUMPTION OF FIRST BANK OF SAGINAW, SAGINAW, TEXAS

The Board of Directors of the Federal Deposit Insurance Corporation has approved the assumption of the deposit liabilities of First Bank of Saginaw, Saginaw, Texas, by Southwest Bank, Fort Worth, Texas.

The failed bank's only office will reopen on Friday, April 17, 1987, as a branch of Southwest Bank and its depositors automatically will become depositors of the assuming bank, subject to approval by the appropriate court.

First Bank of Saginaw, with total assets of \$30.7 million, was closed on Thursday, April 16, 1987, by Kenneth W. Littlefield, Texas Banking Commissioner, and the FDIC was named receiver.

Southwest Bank will assume about \$30.0 million in 6,400 deposit accounts and has agreed to pay the FDIC a purchase premium of \$752,000. It also will purchase certain of the failed bank's loans and other assets for \$20.5 million. To facilitate the transaction, the FDIC will advance about \$8.8 million to the assuming bank and will retain assets of the failed bank with a book value of about \$10.2 million.

The Board of Directors approved the deposit assumption under its authority to do so whenever it determines that such a transaction will reduce the potential loss to the FDIC. The Board made such a finding in this case because of the premium paid by Southwest Bank.

The FDIC will recover a portion of its outlay through the liquidation of assets not transferred to the assuming bank. In this respect, the FDIC notes that its claim will have priority over the claims of nondepositor creditors and shareholders of the closed bank.
