### FDIC APPROVES DEPOSIT ASSUMPTION OF UNITED MERCANTILE BANK, SHREVEPORT, LOUISIANA

The Board of Directors of the Federal Deposit Insurance Corporation has approved the assumption of the deposit liabilities of United Mercantile Bank, Shreveport, Louisiana, by Hibernia National Bank, New Orleans, Louisiana.

The failed bank's six offices will reopen on Friday, January 22, 1988, as branches of Hibernia National Bank and its depositors automatically will become depositors of the assuming bank, subject to approval by the appropriate court.

United Mercantile Bank, with total assets of \$67.3 million, was closed on Thursday, January 21, 1988, by Fred C. Dent, Jr., Louisiana Commissioner of Financial Institutions, and the FDIC was named receiver.

Hibernia National Bank will assume about \$70.1 million in 10,700 deposit accounts and has agreed to pay the FDIC a purchase premium of \$1,150,000. It also will purchase certain of the failed bank's loans and other assets for \$40.3 million. To facilitate the transaction, the FDIC will advance about \$29.8 million to the assuming bank and will retain assets of the failed bank with a book value of about \$27.1 million.

The Board of Directors approved the deposit assumption under its authority to do so whenever it determines that such a transaction will reduce the potential loss to the FDIC.

The FDIC will recover a portion of its outlay through the liquidation of assets not transferred to the assuming bank. In this respect, the FDIC notes that its claim will have priority over the claims of nondepositor creditors and shareholders of the closed bank.
