FDIC ANNOUNCES KEY APPOINTMENTS IN DIVISION OF BANK SUPERVISION

The Board of Directors of the Federal Deposit Insurance Corporation today announced four appointments in the Division of Bank Supervision (DBS): one regional director and three deputy regional directors. Paul Rooney becomes Regional Director in Chicago. New Deputy Regional Directors are: James P. Kielczewski, Chicago; Paul L. Sachtleben, Dallas; and Paul H. Wiechman, Kansas City. The appointments are effective September 29, 1986.

Mr. Rooney has been serving as Regional Director in Columbus; Mr. Kielczewski was Acting Regional Director in Chicago; Mr. Sachtleben was Assistant Regional Director in Dallas and Mr. Wiechman was Assistant Regional Director in Kansas City.

DBS Director Paul G. Fritts said: "The Division is indeed fortunate to have these four talented and dedicated supervisors to fill these important positions. I think Paul Rooney's willingness to again move to another office after two recent transfers typifies the level of dedication of the entire staff and should be especially noted."

Mr. Rooney, 52, a native of Cedar Bluffs, Nebraska, came to the FDIC as a bank examiner trainee in the San Francisco Region in 1961. He held various examiner assignments in San Francisco until 1971 when he was transferred to Washington to become assistant to the FDIC chairman.

In 1973 he returned to San Francisco as Assistant Regional Director, a post he held until he was named Assistant Regional Director in Omaha in August 1980. In June 1984 he was named Acting Regional Director in Omaha and was designated Regional Director on January 1, 1985. In June 1985 he was named

Deputy Regional Director in Kansas City. He moved to Columbus as Regional Director in September 1985.

Mr. Rooney is a graduate of the University of Nebraska with a degree in business administration, and of the Pacific Coast School of Banking at the University of Washington. He and his wife, Patricia, have two children.

Mr. Kielczewski, 47, a native of Erie, Pennsylvania, came to the FDIC as a bank examiner trainee in New York City in July 1962. He became a commissioned examiner in 1967 while working in the Rochester, New York, Field Office. In 1977 he moved to the Madison Region as a review examiner, becoming Assistant Regional Director in the region in May 1979. He moved to the Chicago Region as Assistant Regional Director in September 1984 and has been Acting Regional Director since August 6, 1986.

Mr. Kielczewski is a graduate of Grove City College, Grove City, Pennsylvania, with a degree in commerce/accounting; and of the Graduate School of Banking at the University of Wisconsin. He and his wife, Arlene, have three children.

Mr. Sachtleben came to the FDIC as an assistant examiner in the Chicago Region in 1969. He became a commissioned examiner in 1974. In 1977 he was transferred to Washington, D.C., as a project and planning specialist. He moved to Dallas as Assistant Regional Director in June 1984.

Mr. Sachtleben, 38, a native of Valparaiso, Indiana, is a graduate of Valparaiso University with a degree in business administration. He also is a certified public accountant and is a graduate of the Graduate School of Banking at the University of Wisconsin. He and his wife, Andrea, have two children.

Mr. Wiechman, 49, a native of Cheney, Kansas, joined the FDIC in June 1964 as an examiner trainee in the Kansas City Region. He spent much of his career

in Nebraska where he was assigned to the Kearney and Lincoln Field Offices and to the Omaha Regional Office. He moved to the regional office as a review examiner in January 1973 and was serving as Chief Review Examiner in Omaha when he was promoted to Assistant Regional Director in the Kansas City Region in June 1981.

Mr. Wiechman is a graduate of Wichita State College and of the Graduate School of Banking at the University of Wisconsin. He served in the U.S. Army from 1954 to 1956. He and his wife, Judy, have two children.
