## FDIC ANNOUNCES FIVE EXECUTIVE APPOINTMENTS

The Board of Directors of the Federal Deposit Insurance Corporation today announced the appointment of an assistant director of the Division of Bank Supervision (DBS), a regional director and three assistant regional directors.

Carmen J. Sullivan will serve as Assistant Director of DBS (Corporate Applications and Special Activities). Milos Konjevich, Jr. has been selected for the position of Regional Director of the Omaha Region. The new Assistant Regional Directors are: James Martin, Madison; Donald L. Pfeiffer, Jr., San Francisco, and Steven K. Scholzen, Kansas City.

DBS Director James L. Sexton said: "All the appointees have solid examination and managerial experience and are highly qualified to assume their new assignments."

Ms. Sullivan began her FDIC career in 1970 with the examination staff in the Philadelphia Region. She transferred to the Washington Office in 1975 to serve as a consumer affairs specialist in the Office of Bank Customer Affairs. She was reassigned in 1977 to DBS as Chief of the Administrative Section. From July 1978 to May 1979, Ms. Sullivan also served as Acting Director of the Office of Consumer Affairs and Civil Rights. She was reassigned to be Assistant Regional Director of the Madison Region in January 1980.

Ms. Sullivan received a BBA degree from the University of Texas in 1968, and an MBA from the University of Oklahoma in 1981. She also is a graduate of the Graduate and Post Graduate Schools of Banking of the University of Wisconsin.

Mr. Konjevich joined the FDIC in 1966 as an assistant examiner in the Carbondale, Illinois, Field Office. In 1970, he became a commissioned examiner and was transferred to the Jacksonville, Illinois, Field Office. He was promoted

to Review Examiner in 1975 and transferred to the Chicago Regional Office. In February 1981 he became Assistant Regional Director of the FDIC Minneapolis Region.

Mr. Konjevich holds a degree in Public Administration from Roosevelt
University in Chicago, and is a graduate of the Stonier Graduate School of
Banking at Rutgers University and the School for Bank Administration at Madison,
Wisconsin.

In September 1961, James Martin joined the examination staff of the San Antonio Field Office of the Dallas Region. He became a commissioned examiner in November 1964, and transferred to the Alexandria, Louisiana, Field Office of the Memphis Region the following year. He became head of that office in July 1969. He was promoted to Review Examiner in December 1975 and to Chief Review Examiner in August 1978.

Mr. Martin is a graduate of the University of Arkansas, earning a B.S. in Business Administration in 1961, and of the Graduate and Post Graduate Schools of Banking of the University of Wisconsin.

Steven K. Scholzen came to the FDIC in August 1969 and served as a bank examiner trainee in the Madison, Wisconsin, Region. He received his commission in December 1974 and was promoted to Review Examiner in May 1977. He transferred to the Kansas City Region as a Review Examiner in January 1981.

Mr. Scholzen received his B.S. in Economics from the University of Wisconsin in 1969. He also graduated from the Graduate School of Banking of the University of Wisconsin in August 1982.

Donald L. Pfeiffer became a bank examiner trainee with the Kansas City Region in February 1970. He was reassigned to the Omaha Region in December 1970 and received his commission in April 1975. He was promoted to Review Examiner in the Washington Office in July 1978. In November 1981, he was named Assistant to the Director of DBS. Mr. Pfeiffer received a B.S. in Business Administration from the University of Nebraska, and graduated from the Southwestern Graduate School of Banking at Southern Methodist University.
