### FDIC MAKES PUBLIC OCTOBER 1999 ENFORCEMENT ACTIONS; NO ADMINISTRATIVE HEARINGS SCHEDULED FOR DECEMBER

### FOR IMMEDIATE RELEASE

The Federal Deposit Insurance Corporation (FDIC) today released a list of orders of administrative enforcement actions taken against banks and individuals in October. No administrative hearings are scheduled for December.

The FDIC processed a total of eight final orders in October. These included three cease-and-desist orders, two removal and prohibition orders, one modification of safety and soundness order, one termination of cease-and-desist order and one Call Report penalty.
