FDIC MAKES PUBLIC NOVEMBER ENFORCEMENT ACTIONS; NO ADMINISTRATIVE HEARINGS SCHEDULED

FOR IMMEDIATE RELEASE

The Federal Deposit Insurance Corporation (FDIC) today released a list of orders of administrative enforcement actions taken against banks and individuals in November. No administrative hearings are scheduled for January 2001.

The FDIC processed a total of four orders in November. These included one cease-and-desist order, one civil money penalty, one termination of a cease-and-desist order and one adjudicated decision.
