FDIC MAKES PUBLIC SEPTEMBER ENFORCEMENT ACTIONS; NO ADMINISTRATIVE HEARINGS SCHEDULED

FOR IMMEDIATE RELEASE

The Federal Deposit Insurance Corporation (FDIC) today released a list of orders of administrative enforcement actions taken against banks and individuals in September. No administrative hearings are scheduled for November.

The FDIC processed a total of ten orders in September. These included three cease-and-desist orders, six removal and prohibition orders and one termination of proceeding.
