## **FDIC Makes Public December Enforcement Actions *No Administrative Hearing Scheduled***

The Federal Deposit Insurance Corporation (FDIC) today released a list of orders of administrative enforcement actions taken against banks and individuals in December. No administrative hearing is scheduled for February. The FDIC processed a total of 10 orders in December. These included one cease and desist order, three civil money penalty orders, one termination of insurance, and five terminations of cease and desist orders.
