FDIC Makes Public April Enforcement Actions

No Administrative Hearings Scheduled for June 2015

FOR IMMEDIATE RELEASE

The Federal Deposit Insurance Corporation (FDIC) today released a list of orders of administrative enforcement actions taken against banks and individuals in April. No administrative hearings are scheduled for June 2015.

The FDIC issued a total of 24 orders, one notice, and one decision and order. The administrative enforcement orders consisted of one consent order, one prompt corrective action, four removal and prohibition orders, one section 19 order, four civil money penalties, 12 orders terminating consent orders and cease- and-desist orders, one order terminating supervisory prompt corrective action directive, one notice of hearing, and one decision and order.
