## FDIC Makes Public July Enforcement Actions; No Administrative Hearings Scheduled for September 2017

The Federal Deposit Insurance Corporation (FDIC) today released a list of orders of administrative enforcement actions taken against banks and individuals in July. There are no administrative hearings scheduled for September 2017.

The FDIC issued a total of 24 orders. The administrative enforcement actions in those orders consisted of three consent orders; seven removal and prohibition orders; four Section 19 orders; three civil money penalties; and seven terminations of consent orders.
