REGULATORY RELIEF

Guidance to Help Financial Institutions and Facilitate Recovery in Areas of Missouri Affected by Severe Weather

Summary: The FDIC has announced a series of steps intended to provide regulatory relief to financial institutions and facilitate recovery in areas of Missouri affected by severe storms, flooding and tornadoes.

Highlights:

- From June 12 to July 31, 2010, severe storms, flooding and tornadoes caused significant property damage in areas of Missouri.
- A federal disaster was declared on August 17, 2010, for selected areas in Missouri.
- The FDIC is encouraging banks to work constructively with borrowers experiencing difficulties beyond their control because of damage caused by the severe weather.
- Extending repayment terms, restructuring existing loans or easing terms for new loans, if done in a manner consistent with sound banking practices, can contribute to the health of the community and serve the long-term interests of the lending institution.
- The FDIC also will consider regulatory relief from certain filing and publishing requirements.
