FDIC MAKES PUBLIC DECEMBER 1991 ENFORCEMENT ACTIONS

The Federal Deposit Insurance Corporation today released a list of orders of administrative enforcement actions taken against banks and individuals in December of 1991. The 27 orders released today include 16 cease-and-desist orders, one removal and prohibition orders, three call report penalties, three voluntary terminations of insurance, one termination of insurance, two terminations of cease-and-desist orders, and one modification of a removal and prohibition order.

The orders relating to enforcement actions are available for inspection Monday through Friday, 2 to 4 p.m., in the FDIC's Publications Office, Room 7118, 550 17th Street, N.W., Washington, D.C. 20429.
