### FDIC MAKES PUBLIC MARCH 1992 ENFORCEMENT ACTIONS

The Federal Deposit Insurance Corporation today released a list of orders of administrative enforcement actions taken against banks and individuals in March of 1992. The 59 orders released today include 15 cease-and-desist orders, six removal and prohibition orders, four call report penalties, one civil money penalty, 20 terminations of cease-and-desist orders, six termination of Section 8(a) proceedings, two termination of insurance termination proceeding, one order withdrawing notice of charges, one order withdrawing Section 8(a), and three adjudicated decisions.
