FDIC MAKES PUBLIC JULY 1992 ENFORCEMENT ACTIONS; PROVIDES LIST OF HEARINGS TO BE HELD IN SEPTEMBER

The Federal Deposit Insurance Corporation today released a list of orders of administrative enforcement actions taken against banks and individuals in July of 1992. Also released today is a list of administrative hearings scheduled during the month of September.

The FDIC processed a total of 54 final orders in July. These included 17 cease—and—desist orders, two voluntary termination of insurance, two call report penalties, four removal and prohibition order, five civil money penalties, 14 terminations of cease—and—desist orders, three terminations of Section 8(a) proceeding, four withdrawals of Section 8(a) proceeding, two modifications of cease—and—desist orders and one adjudicated decision.

Five hearings are scheduled for September. All administrative hearings held in connection with enforcement actions taken against insured depository institutions and institution-affiliated parties are required to be open to the public under terms of the Comprehensive Thrift and Bank Fraud Prosecution and Taxpayer Recovery Act of 1990 (the Crime Control Act of 1990). The FDIC will include a list of scheduled hearings, if any, in subsequent monthly press releases on enforcement actions.

A list of the orders made public today and a list of September hearings are attached. The orders relating to enforcement actions are available for inspection Monday through Friday, 2 to 4 p.m., in the FDIC's Publications Office, Room 7118, 550 17th Street, N.W., Washington, D.C. 20429.
