FDIC MAKES PUBLIC OCTOBER 1991 ENFORCEMENT ACTIONS

The Federal Deposit Insurance Corporation today released a list of orders of administrative enforcement actions taken against banks and individuals in October of 1991. The 49 orders released today include 13 cease-and-desist orders, four removal and prohibition orders, nine call report penalties, 13 terminations of cease-and-desist orders, seven terminations of notice to primary regulator (initiation of insurance termination proceedings), two withdrawal of notice of charges and hearing, and one adjudicated decision.
