#### FDIC MAKES PUBLIC NOVEMBER 1991 ENFORCEMENT ACTIONS

The Federal Deposit Insurance Corporation today released a list of orders of administrative enforcement actions taken against banks and individuals in November of 1991. The 38 orders released today include 13 cease-and-desist orders, two removal and prohibition orders, five call report penalties, one termination of insurance, five terminations of cease-and-desist orders, eight terminations of insurance termination proceedings, one withdrawal of insurance termination proceeding, two modifications of cease-and-desist orders and one adjudicated decision.
